BREAD Children's libraries:

We have proposed to set up 125 libraries during the current year. We have already set up 116 libraries in the first six months. 58 of these libraries have been sponsored by Dr. Ashok Kache in Telangana. He has so far sponsored 348 libraries in Telangana of the 475 libraries set up there. Total number of libraries set up by the Society so far is 1142.

Monitoring libraries:

We are now in the process of interacting with HMs and library teachers of schools to ascertain whether they have received the 40 new books sent to them during this year, whether students have borrowed books during summer vacation and read more books by exchanging books among themselves. We are also requesting them to send recommendations for prizes for best write-ups on books.

Governing Body Meetings and AGM 2018:

The 98th Meeting of Governing Body followed by AGM 2018 were held on 21st July 2018 in the office of the Society at Hyderabad. Important decisions taken in the Meetings are given below:

Governing Body has approved Secretary's Report of the activities of the Society and the Audited Accounts for 2017-18. It noted the fact with appreciation that BREAD Society has become a partner of Global Giving Foundation by receiving donations of over \$ 5,000 from 80+ donors. It has also noted the receipt of donations of over Rs. 2 lakh from ImpactGuru (IG).

General Body has adopted Audited Accounts for 2017-18 and has reappointed M/S P Mohana Rao & Co as Auditors for 2018-19. Budget of Rs. 61 lakh for the year has been approved. The following office bearers have been unanimously elected for 2018-20.
